Dear President Concepcion:

The System University Library Council (SUCL), in its 22 November 2022 meeting, approved the endorsement to your Office of the harmonized library fees for incoming first-year students and transferees based on the discussion and recommendation of the *UP System Task Force* on Harmonizing the Office of the University Registrars' (OUR) Procedures Related to Student Progress in its June 2022 Baguio Workshop. For a background of the library fees, please refer to Annex A.

The SUCL specifically endorses the adoption of 1) the Php1,100.00 library fee of UP Diliman, UP Los Baños, and UP Open University for undergraduate programs as approved by the BOR in December 2006; and 2) the Php1,200.00 library fee of UP Diliman and UP Mindanao for graduate programs as approved by the BOR in February 2006 and June 2006, respectively. The proposed fees will supersede the current library fees of UP Constituent Universities, as shown in Table 1.

BACKGROUND

During the <u>1206th Board of Regents (BOR) meeting</u> held on 23 February 2006, the head librarians of colleges in UP Diliman decided to accept the advantage of increasing library fees for entering freshmen, entering graduate students, and entering lateral transfer students effective first semester 2006-2007 pursuant to the recommendation of the BOR that interested CUs may increase library fees upon the approval of the request of UP Diliman School of Economics (*1197th meeting held on 23 June 2005*). This is to improve library collections and in accordance with the Library Book Fund's goals. The Chancellor of the UPD has granted his approval for this.

By the 1197th BOR meeting on 23 June 2005, the automatic approval of increased library fees was reiterated at the <u>1209th BOR meeting</u> on 2 May 2006.

The board was informed of UP Mindanao's implementation of the increased library fees during the <u>1211th BOR meeting</u> on 28 July 2006, which was in reference to the letter from UP Mindanao Chancellor Ricardo de Ungria dated 28 June 2006.

On 15 December 2006 at the <u>1216th BOR meeting</u>, the BOR approved the De Dios Committee's report and increased the tuition and other fees as indicated in the report. It should be stressed that this is only applicable to students entering in 2007-2008.

In the <u>1230th BOR meeting</u> held on 29 February 2008, the BOR approved the proposal of UP Open University to adjust miscellaneous fees rate to Php 2,000 per semester for undergraduate and graduate Programs. In the proposed revision, the library fees will increase from Php 400 to Php 1,100.
